Also present was Debi Pawson, Assistant Secretary/Office manager. Notices had been posted and a quorum was present to conduct business.

Minutes of the previous meeting were approved as distributed.

President Stanton noted with regret the passing of owner John Haile.

#### **Correspondence:**

Letter was received from owner 313 Landscape committee chair person on the progress of the revitalization and up-grading of the current flower beds. It is a work in progress and any help would be greatly appreciated.

## **Financial Report:**

Jim reported on the 10 months operations ending on Oct. 31<sup>st</sup>. We are slightly ahead of budget. We did have a loss of income from the foreclosure of 818. The bank took advantage of a Florida law and only paid us 1% of the outstanding mortgage. We suffered a \$5,000.00 loss from that unit.

More financial information was provided as Jim went into a line by line explanation of the proposed 2020 budget, a copy of which is attached to these minutes.

The budget will have a total increase of 3.028% which will be due to an increase in the amount to fund the reserve account. There is actually a decrease in the operating costs of 0.73%.

Tom negotiated a great deal with the generator company and we must give them a \$30,000.00 deposit at this time to make this point of sale.

Jim opened the meeting to discussion on the proposed budget by board members and those owners in attendance. The discussions were those of praise for the lean budget.

A roll call vote resulted in a 6-0 approval and the budget was adopted.
